



2026 "Ware's the Art?" Display



This is a great opportunity to show off your creative side by featuring items you made with HLC/FTC wares. Maybe you sketched, photographed, or painted a picture of your dishes, created a colorful mosaic, found or crafted a great dish, or invented a clever go-along hack. Now's the time to show off your talents.

Guidelines

1. The display dimensions are 30" wide by 30" deep and up to 48" high, for \$5.00 each. Each table includes skirting and tablecloths supplied by the hotel. You may use your own coordinating material(s) such as tablecloths in your display. Please refrain from including music tracks, strong scented candles or incense, or light strobes. Participants will be able to set up their display Friday evening after the Consignment Auction, or early Saturday morning from 6:00am - 9:00am before room opens to members. Members are welcome to sign up for more than one "Ware's the Art?" display.
2. The display cannot contain the trademark word "Fiesta" or include contemporary backstamps in the art piece(s).
3. Please only display art that was personally created by you.
4. Favorite "Ware's the Art?" Award — Members in attendance will choose their favorite by vote when viewing the displays. Award will be announced and presented during the Saturday evening Gala.
5. The FTCCO license agreement with the Fiesta Tableware Company does not allow exhibiting decaled contemporary Fiesta items that were not produced/authorized by FTC. Fiesta with 3rd party decorations, or rogue items are also not permitted. The FTCCO Board of Directors will kindly ask you to pull any items from your "Ware's the Art?" display that do not meet the terms of the license agreement.



2026 Tabletop Display



Your Tabletop display can include any Homer Laughlin/FTC vintage or contemporary products. Display a small grouping or a centerpiece of your favorite dishes, or present a single placesetting arrangement. This display can be accessorized or decorated with any HLC/FTC or non-HLC/FTC products, including flatware, fabrics, or additional go-alongs.

Guidelines

1. The display dimensions are 30" wide by 30" deep and up to 48" high, for \$5.00 each. Each table includes skirting and tablecloths supplied by the hotel. You may use your own coordinating material(s) such as tablecloths in your display. You are also permitted to drape a tablecloth over the front of the exhibit table. Participants will be able to set up their display Friday evening after the Consignment Auction, or early Saturday morning from 6:00am - 9:00am before room opens to members. Members are welcome to sign up for more than one Tabletop display.
2. Favorite Tabletop Display Award — Members in attendance will choose their favorite by vote when viewing the displays. Award will be announced and presented during the Saturday evening Gala.
3. The FTCCO license agreement with the Fiesta Tableware Company does not allow exhibiting decaled contemporary Fiesta items that were not produced/authorized by FTC. Fiesta with 3rd party decorations, or rogue items are also not permitted. The FTCCO Board of Directors will kindly ask you to pull any items from your Tabletop display that do not meet the terms of the license agreement.
